The Redmond Historic Landmarks Commission (HLC) is seeking photos for the THIS PLACE MATTERS photo contest to celebrate Historic Preservation Month in May. We are calling for photos of BUNGALOWS, specifically photos of you with your favorite historic BUNGALOW, (residential or commercial use) located within the City of Redmond. All photos must include a sign with the words "THIS PLACE MATTERS", preferably being held by you. The signs can be homemade (make sure the words are visible in the photo and we encourage you to be *creative!*) Or you can use our printed signs available at Redmond City Hall 437 SW 9th St. (NEW CITY HALL- administration office).

BUNGALOWS are typically 1- 1 ½ stories, were built in Redmond between 1910-1040, and which include Craftsman, Mission, Tudor, Cape Cod and Modern(e) architectural styles.

CONTEST RULES:

1. One (1) entry per category.
2. Digital or print photos will be accepted.
3. Properties for photo entries must be 50 years old, (circa 1967) or older.
4. Contestants must submit a signed Release Form (provided with entry form) with entry application.
5. Photos must be taken from either the road or the sidewalk. Please respect private property (if you are not the property owner) and do NOT trespass on private property.
6. The contest is open to the general public (HLC commissioners, City staff and immediate family are not eligible to participate in contest, although they are encouraged to submit photos to share their favorite sites).
